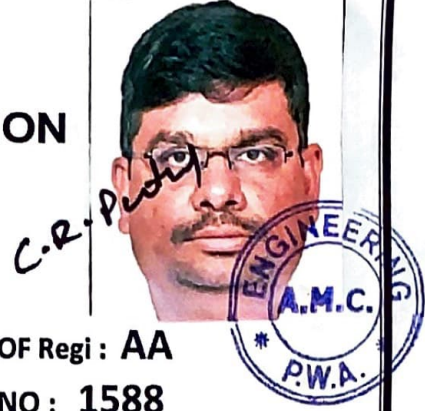

- Your registration / Upgradation or Renewal as an approved Contractor will remain in force for the period up to the end of Financial year **2023-24** i.e. **31/03/2024**
- You will have to set Certificate / Renewal Certificate before the expiry of the period as stated above by submitting the necessary prescribed application for renewal of registration with the receipt of necessary renewal fees duly paid in the P.W.A. Office of engineering department along with document as required as per rules and regulations of registration for failing which your registration will be treated as cancelled.
- Every Change in the Details furnished with the application form, such as change in partners, technical employees, address etc, should be intimated within 7 days to the P.W.A. Office of Engineering department.
- Your name will be liable for removal from the approved list of contractor if you do not make tender for any work during the validity period of registration in various department of State Govt. / State and Central Govt. undertakings, Corporations or Boards for which required certificate will have to be produced.
- After setting the work order from the concern authority to start the work, if the amount of security deposit to be paid as before said is not paid within 10 days from the issue date of work order and the agreement is not executed, the E. M. paid by the contractor will be forfeited, the acceptance of offer will be rejected and his registration will be held in abeyance for three years.
- You will have to obtain a solvency certificate of the amount of Rs. **3,00,00,000/-** or the above mentioned category every year or each financial year by the end of March of the respective Year and furnish the true copy / photocopy of the same with each tender while submitting the same.
- In case where solvency certificate is not obtained, the certificate of previous year will be considered valid up to the end of March of respective year for the purpose of tendering.
- According to standing Committee Reso. No. 878 Dated 6-1-2001, the bidder has to pay 1% as aE.M.of the contract amount in demand draft only.
